


Figure 1: Enhance the Value of Your EOS 360 Reports with A&AS

- 2. A&AS securely integrates with EOS 360 via web services hosted on your organization's web application server, eliminating the need for a GUI or EOS Access interface.
- 3. Using a dedicated technical user profile with admin privileges, A&AS ensures secure and efficient data retrieval from EOS 360 reports.
- 4. Extracted data is processed through A&AS, validated against predefined business rules to guarantee accuracy, completeness, and compliance.
- 5. The verified data is automatically transferred to downstream systems, enabling end-to-end workflows without manual intervention.
